1.0 INTRODUCTION

Rapids Jet (2004) Limited have held a concession to locate facilities on the Aratiatia Rapids Scenic Reserve since 1999. The current 10-year concession expires on 2 April 2023. They have constructed and maintain a carpark, visitor centre, toilet block (fully contained), and walking track on the reserve.

The jetty and jet boat activities are located off public conservation land on the Waikato River, managed by the Waikato Regional Council. Rapids Jet hold all the necessary permits from the Waikato Regional Council and Maritime New Zealand to operate a jet boat business on the Waikato River.

Rapids Jet are applying for a new concession to lease 1 hectare with a 30-year term to provide greater certainty for the business.

This environmental impact assessment is prepared as part of the concession application.

2.0 DESCRIPTION OF THE SITE

The site to be leased is in the Aratiatia Rapids Recreation Reserve. This is located beside the Waikato River below Huka Falls and the Aratiatia Rapids, 15 km north of Taupo.

Aratiatia Rapids Recreation Reserve is located on a river terrace. The vegetation is predominantly grass. In 1993 12,000 native plants were planted. There is also 20 hectares of Douglas Fir (Pseudotsuga menziesii) planted.

There are a number of plant pests including pines. Lupin, broom, gorse and Himalayan Honeysuckle. Animal pests include rabbits, hares and possums.

Nga Awa Purua Road is sealed and runs through the reserve. It provides access to the Nga Awa Purua geothermal power station which is a joint venture between Mercury Energy and Tauhara North No.2 Trust.

The reserve provides access to the Waikato River for fishing and kayaking.

The Fiber Fresh National Equestrian Centre is located adjacent to the reserve. The Centre leases 39 hectares of the reserve to graze horses and locate jumps.

3.0 DESCRIPTION OF THE CONCESSION

The primary purpose of the concession is to lease 1 hectare of the Aratiatia Rapids Recreation Reserve to locate visitor facilities associated with a jet boat operation. The jet boat operation occurs off public conservation land on the Waikato River.

The current visitor facilities are;

- Gravel driveway and carpark.
- 141 m² visitor centre and deck.
- 31 m² fully contained 4-pan toilet block (all effluent is contained, pumped out and removed off site).
- 50 metre walking track from visitor centre to Waikato River.
- Underground power supply and phone line.

Note – the jetty used to load and unload passengers from the jet boats is located off public conservation land and is operated under a permit issued by the Waikato Regional Council.

In addition, it is proposed to;

- Install a 20 m² extension to the visitor centre to provide an office work space.
- Install a building for safe and secure boat and equipment storage. This shed will be located at the rear of the site to minimise any visual impact and will be 12 metres wide by 12 metres long (144 m²).
- Install a sign on the corner of Aratiatia and Nga Awa Purua Roads.
- Seal the driveway and carpark.

5.0 Summary

- The purpose of this concession is to lease 1 hectare of Aratiatia Rapids Scenic Reserve.
- Visitor facilities are currently located on the site.
- A 20 m² extension will be added to the existing visitor centre.
- A new storage shed will be constructed. This will involve minor vegetation removal and earthworks.
- A sign will be installed.
- The driveway and carpark will be sealed.
- The actual and potential effects of the proposal on the immediate and surrounding environment have been assessed as being no more than minor.
- The proposal is consistent with the Tongariro Taupo Conservation Management Strategy.
