

The application will have adverse effects on the natural environment incompatible with the rest of the area's natural values and reasons for being protected.

Adverse effects will include noise, air quality (open fire smoke through the valley), loss of vegetation, amenity and visual effects, habitat, and species and ecosystem impacts, that can't be sufficiently mitigated or remedied. The high standard of current amenity and protection in the area means the habitat and wider environment is highly sensitive to the impacts of human intrusion. The base line in the area is one of isolation and solitude. Built structures and formal inhabitation and accommodation will diminish those values. This is in both effect, and in the way people will view current National Park protections – affecting the 'sacred' nature of these places and the rules designed to protect them. Approving this application will negatively impact on the quiet and wild nature of this place, but also how New Zealanders can see National Parks' protection working (in the negative).

- [i] possible exclusive use of carpark, no consultation detail
- [j] lack of any measurements of any structures
- [k] lack of any specific building plans
- [1] concept drawings depict large north facing glass walls, will these give off glare up the Eglinton River
- [m] no scale of distance on any maps
- [n] access track only for quad bikes. Get real, a 20 minute walk in Fiordland rain will soon force owners for a departure of plan for a road. Let's be honest.
- [0] however it is dressed up, this is just another motel in an undesirable location
- [p] from an angling club perspective, the probable conflict of anglers accessing the river from the Dore Pass Route being cut off from their days fishing by anglers coming from the proposed development.

Submission in Relation to Path NZ application for Concession to Build Accommodation, within Fiordland National Park.

Firstly I feel, it would be of benefit for me to give the department staff considering this application a summary of the history of pre-existing accommodation within Fiordland.

I have worked (until recent retirement) in Fiordland for over fifty years, within tourism and facility management, and have a deep understanding of Fiordland History.

The most recent accommodation, built within the National Park, was associated with the construction of the Hump and Kepler Tracks, five huts sleeping up to sixty people.

Prior to this, there was major accommodation built at West Arm and Deep Cove as part of the Manapouri Power Scheme construction. At the end of the project a hostel for single men was built at West Arm.

A hostel building at Deep Cove was made available for the use of Southland School children on the suggestion of the Late Sir Less Hutchins. This building has been replaced with the existing building in the 1980s. This hostel was built and operated by Fiordland National Park Board / Lands and Survey until the mid 1990s, It was then sold for \$1 to the Deep Cove Hostel Trust and if it was not for the company set up by Sir Les Hutchins it would have cease to exist many years ago.

Boarland Lodge, was built as a construction camp, just on the boarder of the park and has been operated by a trust since the power scheme finished for school use also. This facility has been rebuilt over the last thirty years, with the support of Southland Service Clubs. Southland schools have been exceptionally well provided for, with both these facilities and children have had a great appreciation of our National Park for the last forty years.

During the early 1960s Fiordland National Park Board established a series of huts around the Fiordland Lakes for the use of hunters and fishermen, a total of seven new huts were built, to add to existing huts built by tourist operators using the lakes since the late 1890s

During the construction of the Milford Road in the 1930s, several sites along the road line had sizable construction camps, built to support the large workforce. The existing facilities at Knobs Flat, Gunns Camp and Milford Lodge, at Milford Sound, all started from these camps. They have been upgraded and new facilities built on the original sites. A tourist facility was for many years operated at Cascade Creek, until the creek management became un -tenable.

The Milford, Routeburn and Hollyford Tracks have had accommodation built over the period from the 1880s to the mid 1940s. These started of being very basic bush huts, but over the years have been rebuilt to be more in lined with small hotels. The Fiordland National Park Board also built a series of huts along all these tracks to cater for non guided walkers, again these have been upgraded and extended over time to better cater for todays users. Not everyone has the ability or time to walk these tracks, so a facility similar to any of these modern lodges, just a short walk from a access point would be of benefit.



The Milford Hotel was established by Donald and Elizabeth Sutherland, to cater for Milford Track walkers, this was replaced in 1928 by the NZ Govt as a hostel to cater for the track walkers. It was replaced again in 1954 by the Govt, to bring it up to a high standard for the new wave of tourist using the newly opened Milford Road. It was sold off in 1987 and is today used only for the guided Milford Track walkers last night. This is one of the prime sites within Flordland and is not use to anywhere near it potential. Milford Sound has very limited land available and it is at present, not best used.

The application from Path NZ will be the first ever application for building accommodation within Fiordland National Park, that does not have any association with historic tourism links. At this point I would like to quote an early Fiordland Tourist Pioneer, the late Mr Wilson Campbell, "For 85% of the people using the road to Milford, this is likely to be, the only wilderness experience they will ever have", this is in my view, so very true. Some can stay at the existing accommodation along the road or camp at the DOC campsites, but the services planned by Path NZ are not available at any other provider along the road.

It will give clients a similar experience to walkers on the Great Walks, but be available, after just a short walk to a site that cannot been seen from the Milford Road, so in a sense, they could be anywhere in Fiordland.

The Department of Conservation has spent millions of dollars, working to make the biodiversity within this valley unique, having somewhere for people to stay in nice facilities, so they will be able to appreciate the great work the Department has done. This would be a win- win for all concerned and could even provide more support for the Departments work. The operators could set up a programme, similar to the very successful donation project for biodiversity work, carried out by the hut staff at Lake Mackenzie Hut.

The Milford Road is the shop window for Fiordland National Park and was in the early National Park time a place Rangers spent a lot of time relating to users. This has declined since the exception of DOC. The existing tourist operators have in some cases taken over this very important role and the concepts of Path NZ is so much in line with early park management policy.

I support the concept planned and it would provide any experience that is both required for modern tourist and not provided by any other tourist operation today.



There is no reason for this luxury lodge to be located within the boundaries of Fiordland National Park. There are already plenty of accommodation options within FNP such as Knobs Flat, Gunns Camp, Milford Lodge, Mitre Peak Lodge as well as DOC huts and guided walkers lodges on the great walks. Ms Hutchins quotes Professor Norton's report Path: Vegetation assessment & general comments on terrestrial environmental impacts, saying that "having a more permanent human presence in the area should help restore and protect the forest and birdlife". This is fundamentally wrong. It is the human expansion into the wilderness that brings loss of natural habitat for native species and introduces pollution and predators that are detrimental to our native flora and fauna.

Rather than introducing more islands of civilisation into the National Park, we should make better use of those areas already sacrificed for the comfort and convenience of people.

Adverse effects on visual, noise and light pollution

Visual, noise and light pollution will extend over the entire lifetime of this project and not just be limited to the building stage.

The proposed vegetation clearance on the site of the building and the carpark means the site could be in view of those walking up the Dore Pass. Even if the buildings would not be visible to people passing by on the Milford Road, the smoke from log burners and diesel generators would be visible from any point in Eglinton Valley and beyond. And of course the exclusive carpark will be there in full view from the road, attracting curiosity of some passers-by as to what purpose it serves.

The generator noise would be a continual, and add to it intermittent, but equally annoying noise of a quad bike, not to mention helicopters delivering goods and taking away waste. Some customers would probably arrive by helicopter as well adding to the already busy air traffic in this area, particularly over the summer months.

Light pollution could be substantial in winter months when days are short, if the lodge is to operate whole year round. In any case artificial lighting after dark may have adverse effect on local fauna.



SUBMISSION ON APPLICATION 64177 ACC - PATH NZ LTD

I oppose this application due to the following:

- 1. I consider this application for a commercial tourist lodge to be developed within the Fiordland National Park is incompatible with the Conservation Act 1987, which makes it abundantly clear that this type of activity is well down the pecking order of what is appropriate within a national park. It is clear within the Act that recreation is subordinate to conservation, and tourism is subordinate to both conservation and recreation. Therefore if this application were to be approved it would set a dangerous precedent for similar commercial ventures to be permitted on conservation (public) land. Te Anau Downs, which is outside the Fiordland National Park, is the most logical site for such accommodation where a loop nature trail has already been established around Lake Mistletoe.
- 2. Continuing on regarding the Milford Road, at present there is a comprehensive study being undertaken (Milford Opportunities Project) which, as well as a master plan being developed for Milford Sound, is also looking at future appropriate development along the Milford Road. This application, particularly its exclusive carpark for thirty vehicles, could compromise the findings of this inter-agency initiative.
- 3. This application could also compromise on what MDA is intending for the ex MOW depot at Knobs Flat about 4km south of this proposal. On this already modified site the existing accommodation is to be upgraded and expanded in the near future so that more visitors will be encouraged to experience both earlier and later cruises at Milford. This is a sensible and logical venture and surely dovetails into the Milford master plan.
- 4. The application discusses the feedback received from appropriate stakeholders; however, there is no mention regarding the position the Southland Conservation Board has taken on this proposal. I consider that this is extremely relevant as the Board has a statutory role in the implementation of the Fiordland National Park Management Plan.
- 5. The physical attributes that dominate the surrounding landscape of the proposed commercial lodge include a spur line that extends out from the higher land to the east. The axis of the spur line is orientated in a west and east direction. To the south a dip slope falls directly down to the Eglinton River. Towards the north a terrace riser falls gently to a floodplain that boarders the Eglinton River. Periodically incising through the floodplain are spring-fed streams that wind their way towards the river. The character of the river adjacent to the proposed lodge is generally multi channelled that helps to form numerous braid islands and gravely bars. In a wider context the river's channel includes a sequence of short riffles, long flat pools and deep corner holes that typically feature beach log jams. A boggy swale gully runs parallel with SH94.



- The applicant's plant ecologist describes the vegetative patterns comprehensively with the spur line being dominated by an uncomplex beech community, while the terrace riser contains a subtle mixture of native and introduced grasses. As correctly stated in the application, the Eglinton valley was lightly grazed during the summer months until about thirty years ago. Visually the native and exotic grasses fuse together with signs of reversion back to a natural state becoming more obvious. The hard edge that defines the exterior margins of the beech forest is due to this shallow terrace riser being a cold air drainage zone. This is supported by the consultant ecologist who commented that a full plant survey could not be carried out because of the frost cover, and a provided photograph clearly shows ice needling and permafrost. The actual site for the lodge is located on fragile moss/lichen patterned ground, which is inherently difficult to reinstate after the ground's crust is disturbed.
- A list of birds that were observed during fieldwork has been provided. 7. This list is incomplete, as I have observed a localised population of rifleman in the mature red beech stand along the spur crest. The introduction of more human activity in the area, e.g. regular helicopter movement, would surely have an adverse affect on this small, discreet forest bird. At the southern end of Knobs Flat there is a population of mohua; it is not known if there have been any recorded sightings of this threatened native bird further north towards the proposed site for the commercial lodge. Occasionally both kaka and NZ falcon can be either heard or seen flying in the vicinity of the proposed lodge. In spring, the long tailed cuckoo has been heard along the margins of the beech forest near the Eglinton River.
- I consider this tourist venture to be completely incompatible with the 8. existing traditional recreational use of this section of the Eglinton valley, this being backcountry angling. The mid reaches of the Eglinton River are treasured by anglers due to the overall sense of peace and feeling of remoteness. At this point the river averages about 1km away from SH94. An accompanying report suggests that a mitigation technique to help screen the tourist lodge from traditional recreation users is to plant shrubs along the river's margins. This would be impractical owing to the inherently slow growth rate of shrubs in the valley floor, with local entanglements of mingimingi being about 1 metre in height. These shrubs could be at least fifty years old. To avoid browsing, the screen planting would probably require protection sleeves; this would look too contrived in this natural setting.
- Furthermore, the "domestic" elements associated with this proposal would 9. have an adverse effect upon traditional recreational users. The cumulative effects include:
 - The inversion layer of smoke from the open fires as shown in the sketches of the proposed tourist lodge.
 - Frequent helicopter activity.
 - Miscellaneous signals of habitation, e.g. revving of quad bikes.
 - Noise from diesel generator.

- Voices of guests using the proposed nature trail that encircles the spur crest.
- Informal tracks being created between the tourist lodge and the river margins.
- Introduction of substantial built forms into a natural environment where at present there are no-man made elements except predator control markers.
- 10. The application states that the proposed tourist lodge is far enough away from SH94 not to hear traffic noise, and to be able to hear the river and birdsong. In reverse, the traditional recreation users would be exposed to noise from human-induced activities associated with a tourist lodge.
- 11. By targeting guests with a high disposable income it is considered that the location for this venture is impractical owing to the fact that many of the guests may not be equipped to walk 500 metres, with their luggage, to the lodge, not to mention the added inconvenience associated with inclement weather and clouds of sandflies. The access track would have to be of shoe standard, e.g. hard metal capping. Low LED lighting would have to be provided from the carpark through the beech forest to the lodge. No details are given on how fire and emergency services would have rapid access to the lodge. No site for a helipad is located on the provided diagrams. The proposed exclusive carpark for thirty vehicles will require a substantial number of mature beech trees to be removed along SH94. This will result in an unsightly indentation in the existing scenic avenue of trees. In addition, removing the edge beech trees that normally have a wider root plate will make the interior trees more vulnerable to wind throw. This phenomenon is noticeable where improvements to SH94 has included the removal of large edge trees.
- 12. Lastly, I consider that this application is fundamentally flawed. Although a plant ecologist has provided a report I consider that an assessment should have been carried out by a suitably qualified person to evaluate the landscape/visual impact this proposed commercial venture would have on the surrounding natural environment. I consider this area is high in natural character, which can be described as the expression of the natural traits, patterns and processes in a specific location. It is my view that this is a visually sensitive area, making the domestication of the site completely inappropriate, with the natural "feel" of the mid section of the Eglinton valley being compromised.
- 13. In conclusion, I consider this application should be declined in its entirety.







I oppose the application by Path NZ Ltd to build accommodation facilities and operate associated services in the Eglinton Valley, Fiordland National Park.

The reason for my views are that I believe NZ's National Parks' primary purpose should not be commercial wealth generation for private individual benefit but the preservation and conservation of nature, enhancing biodiversity, while allowing for the enjoyment and appreciation of nature by visitors. Visitors should be managed so that they cause no or very low impact on the natural values, in keeping with the main purpose of our parks. This is the principle upheld in our National Parks Act, which is binding to the Crown. I refer the reader to this excerpt from the National Parks Act 1980 (includes my own underlining of especially relevant wording): "...

Part 1

National parks

Principles to be applied in national parks
4Parks to be maintained in natural state, and public to have right of entry

(1)

It is hereby declared that the provisions of this Act shall have effect for the purpose of preserving in perpetuity as national parks, for their intrinsic worth and for the benefit, use, and enjoyment of the public, areas of New Zealand that contain scenery of such



distinctive quality, ecological systems, or natural features so beautiful, unique, or scientifically important that their <u>preservation</u> is in the national interest.

(2)

It is hereby further declared that, having regard to the general purposes specified in subsection (1), national parks shall be so administered and maintained under the provisions of this Act that—

(a)

they shall be preserved as far as possible in their natural state:

(b)

except where the Authority otherwise determines, the <u>native plants and animals of the parks shall as far as possible be preserved</u> and the introduced plants and animals shall as far as possible be exterminated:

(c)

sites and objects of archaeological and historical interest shall as far as possible be preserved:

(d)

their value as soil, water, and forest conservation areas shall be maintained:

(c)

subject to the provisions of this Act and to the imposition of such conditions and restrictions as may be necessary for the preservation of the native plants and animals or for the welfare in general of the parks, the public shall have freedom of entry and access to the parks, so that they may receive in full measure the inspiration, enjoyment, recreation, and other benefits that may be derived from mountains, forests, sounds, seacoasts, lakes, rivers, and other natural features.

5Indigenous plants and animals to be preserved

(1)

No person shall, without the prior written consent of the Minister, cut, destroy, or take, or purport to authorise any person to cut, destroy, or take, any plant or part of a plant that is indigenous to New Zealand and growing in a national park.

No person shall, without the prior written consent of the Minister, disturb, trap, take, hunt, or kill, or purport to authorise any person to disturb, trap, take, hunt, or kill any animal that is indigenous to New Zealand and found within a national park. "

I do not see the establishment of a luxury hotel or any other type of hotel in the Eglinton Valley as a low impact activity. The preparation of a building site would necessitate destruction of native flora and fauna currently occupying the site, which obviously conflicts with the National Parks Act quoted above. Additionally, there would be ongoing impacts; to the visual amenity of the area, which conflicts with the National Parks Act's provision for preserving the parks in their natural state, as quoted above. The provision of electricity, management of waste water and sewage and allowing for the transport of guests to and from the site would all cause ongoing disturbance. The area in and around the accommodation would likely be managed as exclusive use for paying guests only, which also goes against the principle of free access by the public to the park. I don't think any of this can be justified.

While there is precedent in other accommodation operations located in national parks (for example the Hermitage Hotel in Mt Cook National Park), these are mainly not recent developments. The Hermitage was established long ago, before the Mt Cook National Park was established, and thus the rules we now have to protect our parks did not exist. Further, park or no park, what may have been ethically acceptable in 1884 is not necessarily the best thing to emulate in 2018. The world in 2018 is much shorter on wilderness than it was in 1884, and there are now many alternative hotels available. With modern transport options we now have the ability to visit what were once remote sites in the national parks as day trips, from convenient accommodation sited outside the park. When The Hermitage opened, it required a three-day, horse-drawn coach journey from Timaru to access. Now, In contrast, the central Eglinton Valley is only a 45 minute drive from Te Anau township.

The applicant may claim there is demand for such an accommodation facility but supply and pushy marketing does tend to create demand, whether there was originally any such demand or not. Our planet now has a burgeoning human population and if even a tiny fraction of our fellow inhabitants could be convinced to visit such a hotel, the rooms would be filled and your applicant would be vindicated in any claim of a "demand". Just because such a business could be viable, some visitors might enjoy it and one company could make a profit does not mean we should go ahead and allow it however.

Our parks are a shared public facility and we the public do not deserve to have our clean, uncluttered parks filled with the messy human paraphernalia of built-up commercial developments. If this application was to be granted, I imagine it would set a precedent for a rush of similar applications, all hoping for similar opportunity. How could the Department of Conservation then fairly refuse these if Path NZ Ltd's application had been accepted? A proliferation of human developments in our parks is completely undesirable in my view. Visitor accommodation, even roadside campgrounds, should be kept outside of the parks as far as possible. In this case there is much adjacent private land offering alternative sites to Fiordland National Park land, within a 20 minute drive of the site concerned. It is in no way justifiable to offer the use of Fiordland National Park land for additional hotel beds. This application for development must be refused.

In the face of rising pressures from tourism and exponential world human population increase, it is more important than ever that we uphold our protective rules and don't allow exceptions. That way we ensure our parks remain beautiful and un-spoilt by human development. Generations of future New Zealanders, hopefully hundreds of years into the future, will be thankful for the opportunity to enjoy our heritage - national parks in their natural state.





- The argument that it will relieve congestion by spreading the load on the Milford Road;

- The argument that it will give people an increased appreciation of the environment and they will learn the value of conservation:
- The argument that there is a need to site this lodge on this publicly protected land and that there are no other possible sites;
- The arguments that there are other buildings and car parks in the area.

My submission is [include the reasons for your views]:

- 1. There should be no private commercial buildings in national parks of such a fragile nature as Fiordland. The park and Te Anau both have hurdles in coping with rapid growth in tourist, worker numbers and house building. The natural environment, including Lake Te Anau, are under threat. Surely it would be reasonable to adopt a cautionary model and state that peak development has been reached in the park and efforts should not go into minimising the impact of humans on the natural environment.
- 2. The developer argues throughout the submission that there are many developments along the front of the Milford Road. Many of the development are from an earlier era long before New Zealand was serious about having a conservation estate. Later developments, like DOC campsites, are all public owned and accessible by the public and help contain random camping that could spoil the area.
- 3. The location of this proposed development is not far from a gateway town Te Anau with the established infrastructure required for an accommodation facility. Any type of settlement is an imposition on the environment so, as a country working on conservation of our land and species, we should not add any more settlements than necessary. Indeed, we should strive hard not to. Development should be concentrated outside the park, not inside.

New Zealand must learn to differentiate between what is good for a business, that is earning dollars, and what is good for the land and its future. In this case the decision on whether this business should go ahead should favour the land. It has already been designated for conservation, why now allow others to nibble at it. DOC must hold the line. Less is best.

The benefit to having a gateway town, rather than development in the park, should be

considered and work has been done on this. Some analysis is mentioned here:

"Gateway communities play an important role in the protection and management of natural

areas in several ways, through providing services for visitors and, therefore, keeping commercial development and visitor infrastructure outside park boundaries (although some gateway communities are located within protected areas), and through providing economic and political support for the protection and management of park and protected area resources (e.g. communities with financial ties to a resource have an inherent interest in protecting the resource,

because the quality of the park is the primary tourism product)."

- 4. I see nothing convincing in this application as a reason to site a lodge in an untouched setting like this in the national park. There are alternatives nearby in fact there are magnificent vistas and bush coverage around Te Anau where guests can savour a feeling of serenity.
- 5. The proposal appears to be for accommodation and meals. The guests will only be there in the evenings therefore this setting is not essential. Indeed, the developer says guests will be doing the short walks in the Milford Road area and will come to the lodge later in the day.
- 6. Too much is being made out of the lodge bringing some relief to the overloading of the Milford Road. With 40 guests at the lodge, and still a drive from Milford Sound, it would make little impact on reducing traffic. The solution for traffic overload is something much more radical like stopping private vehicles going to Milford and taking everyone by bus. This is a conservation approach reducing traffic nuisance, crashes, vehicle noise, and enhances the visitor experience. This development is adding to traffic by removing the Te Anau to Milford bus option.
- 7. The developer claims they will add jobs for locals. There are no locals in this location, which means they would have to drive from Te Anau. This would be too costly for local workers on the minimum wages that tourist facilities pay. The likelihood is the lodge will hire overseas backpackers. The siting of the lodge encourages a reliance on foreign workers. This is clearly evidenced by the provision of onsite staff accommodation demonstrating the intent is to hire people from outside the area who do not have homes and a family to go to each night.
- 8. I owned accommodation businesses in Kaikoura for 10 years. The overwhelming attraction of New Zealand to most tourists is our landscapes. Sit down and have a chat to them. They will talk about all the buildings throughout Europe and Britain on the lowlands and the hills. They will talk about driving for miles in NZ without seeing a house. This is the attraction of New Zealand. Let's not ruin it.

Others have described it more eloquently: 'A cherished corner of the world where mountains and valleys compete with each other for room, where scale is almost beyond comprehension, rainfail is measured in metres and scenery encompasses the broadest width of emotions'.

The developer says these buildings will not be visible from the Milford Road, but there will be a road developed and signage, and there will be "creep" from future developments so eventually buildings will be in the open. By allowing this and future developments the visitor experience is being compromised. They will be visible from the air.

- 9. It is disappointing that the developers see no difference between DOC huts and this proposed lodge. The claim they are the same because fees are paid to stay in the huts. They should recall that for generations tramping huts were free and the public helped maintain them indeed some were built by tramping clubs. It was the neoliberal governments that brought in charging and put a business model into our conservation estate. This might change but I do not see this planned lodge becoming a free public facility at any time. And let's remember that DOC huts require people to walk in. That's part of the special experience and indeed gives everyone "an increased experience of the environment" which their lodge will not do. This development cannot be compared with a tramping hut.
- 10. I object to the public being locked out of any part of the national park because a private owner wants to do business there. The developer states they want exclusive use and suggest the limit on freedom camping should be extended out to include their access way.
- 11. There seems to be a lack of consistency with DOC policy in other areas, in the fact that DOC is actually considering this proposal. In the Abel Tasman National Park long time privately owned baches had to be removed once the owner had died. Why then would DOC allow a private owner to build on another national park.
- 12. It is disappointing that the developer believes their lodge will help people learn the "value of conservation". That's ironic when they will be disturbing the publicly protected conservation estate. This private developer wants to cut down trees, clear land for a car park and discharge brown and grey water into the land. They present pictures of public car parks to show that it is done elsewhere, for example the Lake Marian car park. They propose a private facility, a private car park for exclusive use, not for the public.
- 13. One of my favourite drives in NZ is the Milford Road. I have been there many times outside the frantic tourist season. Please don't allow any more buildings. If you do this will be the beginning of the end. By granting the application DOC will set a precedent and will not be able to turn down future applications. In years to come they will be dotted along that glorious highway. A tragedy.

Our submission is that you do not grant the submission due to the following:

The Eglinton valley has long been of great value to anglers with the relative ease of access to an excellent fishery that offers the feeling of remoteness in a largely untouched and unspoilt environment. New Zealand Professional Fishing Guides Association (NZPFGA) members have been using this river since our inception in 1977 (and likely before) to entertain guests looking for the solitude and excellent fishing this unique valley offers.

The NZPFGA membership is 161 strong and is based in all regions of New Zealand. The majority of the Southland and Otago regional members utilize this fishery during the course of the fishing season from 1st Nov - 31st May each year as a NZ highlight for their clients. Many members from other regions also choose to use the Eglinton river while on extended trips with clients.

It is a very important and well used fishery for members of the NZPFGA.

Section 5.3.9.2 Miliford Road of the Fiordland National Park Management (FNPMP) states " proposals must still consider effects on the natural environment and existing recreational opportunities." The proposal has not considered the large impact that it will have on anglers both guided and unguided.

Section 5.8 of the FNPMP states (under Objectives) "2. Consider recreational facility development proposals within Flordland National Park where they are consistent with national park values, including the visitor group and visitor setting in which the facility is to be located, and do not compromise the recreational experiences associated with neighbouring areas through the displacement of existing user groups."

The NZPFGA as concession holders would be adversely affected and seriously compromised by granting the application as it will effectively displace us as historical users.

2. Location of site and status of lend

The experiential component of anglers will be severely eroded by the erecting of the buildings, fuel tanks, car parks, nature trail and access road that will be in both sight and noise reach of anglers.

Section 5.3.9 Frontcountry Visitor Setting of the FNPMP states "Travellers' accommodation facilities may also be appropriate in these visitor settings although the preference would generally be to have new facilities located at already modified altes." The applicant's preferred site is completely unmodified and should remain this way.

The applicant suggests that the public would be challenged to access this area easily. Many anglers including guides access the Eglinton river from the Dore Pass car park and fish up to the point where the river returns to parallel the road. The proposed site is right in the middle of this section. Guided anglers often use existing trap lines and deer trails which make for relatively easy access to points on the river and/or to exfiltrate from the river. This will create the serious potential of conflict with applicant's guests making unwelcome intrusions into the otherwise solitary activity of fly fishing. Of high value for most freshwater anglers is the ability to remove oneself from the hustle and bustle of other humans and their doings to be immersed in nature both physically and psychologically.

The upper reaches of the Eglinton river have suffered from flooding over the years, resulting in a loss of freshwater fisheries habitat. Trout population density declines rapidly 1 km above the Murcott burn. This indicates that the area around the Murcott burn is vital to supporting a fishery in the upper river and continuing to provide the type of experience that anglers from all around the globe come to enjoy.

As per the Conservation Act 1987 Department of Conservation (DoC) is responsible for protecting freshwater fisheries habitat. Granting the submission is highly likely to have adverse effects on a very important part of the river and therefore likely to cause harm to the freshwater fisheries in the area.

Guided fishing is an extraordinarily non invasive usage of the Conservation Estate where guides and their





complex is not only permanent but will alter and damage the landscape forever and do the same to the guided anglers experience in this valley.

3. Privatisation of Conservation Estate

The applicant is essentially seeking permission to operate a series of private accommodations at the proposed site on public land for commercial gain and private profit to the detriment of all other users and especially those of historical usage such as NZPFGA membership.

This is contradictory to the section 6.12 Private Huts of the FNPMP which states "Private huts are considered inappropriate in national parks as they appropriate public resources for exclusive private benefit and are not consistent with the National Parks Act 1980. Private huts can have an adverse effect on the environment and other users' enjoyment of the area. The presence of inappropriate buildings in a natural landscape can lessen its natural character, as can the effects of inappropriate rubbish and sewage disposal and change to vegetation and landscape. There is also a general reluctance by the public to visit areas occupied by private huts. National park land is public land."


in fact the FNPMP 6.12 Private Huts states "Objective 1. To gradually remove inappropriate private huts within Fiordland National Park. Implementation 1. No new private huts should be allowed to be constructed within the Fiordland National Park".

Guided angling does not privatise any part of the Conservation estate yet makes a significant economic contribution to the New Zealand economy. If successful this submission will have considerable impact on the dollar spend of visiting anglers in the Southland/Flordland region and will be to the detriment of the current concession holders (NZPFGA membership) and the region as a whole.

The applicants are asking for exclusive possession. This is in contradiction to FNPMP which states in Section 5.3.9 "The provision of facilities in the frontcountry encourages accessibility by ail".

There are provisions in the Conservation Act 1987 that direct DoC to provide existing concessionaires due consideration before granting any concession. We ask that as concessionaires that the NZPFGA are given due consideration and the outcome be that the applicants submission be denied.



The proposed lodge, carpark and access track are in an area with few human structures. They would impinge on the Egilinton Valley's overall sense of naturalness and create a new built area deeper in the Park, beyond the last settlement at Knobs Flat.

I am submitting against the proposal to defend our national parks – places set aside for their intrinsic worth. This isn't the first time companies have tried to erode that basic tenet, from inappropriate helicopter landings to hydro schemes. 

My submission is [include the reasons for your views]:

- 1. The proposed development contradicts policies for accommodation in section 9 of the General Policy for National Parks. This policy states that applicants should place accommodation outside of the park or share existing facilities (9d). An example of the planning and administrative complications that arise from private accommodation in national parks is the current issue of the Canterbury Mountaineering Club Wyn Irwin hut in Aoraki Mt Cook National Park. Surely the Department has learnt that it is best to avoid future hassles and potential conflict from private accommodation within national parks?
- 2. It is exclusive, private accommodation within a national park. It contradicts policy 9(e) which provides that any new facilities are not for exclusive use and provide for public use.
- 3. It contrary to the Flordland National Park Management Plan; specifically, the objectives for Milford Road, (section 5.3.9.2 13 page 176).
- 4. This building complex reduces the naturalness of the Eglinton valley for other users. Even if it cannot be seen from the road, the signage and cars in the carpark all point to the presence of the lodge and diminish the perceived wildness of the landscape.
- 5. We are not convinced that there is no alternative to this site. There are other ways to stay in the Eglinton valley and experience the natural landscape. Has the applicant explored alternative private land sites on the Park boundary with similar landscapes and sense of naturalness, for example, the Chartres family station at Te Anau Downs?
- 6. We believe it is best if private buildings in the National Park are clustered together, for example at Knobs Flat. This reduces visual impact, provides a "village-like" complex, and allows for cooperative provision of power systems, sewerage disposal, fire-fighting infra-structure, and emergency planning. A compact cluster reduces the combined environmental and visual footprint.
- 7. We do not believe sufficient evidence has been provided to show that sewerage disposal can be achieved with minimal environmental impact. In fact, the solution put forward seems to require a dispensation from the Council's standard for secondary treatment. The additional information suggests that sub-surface dropper irrigation systems may be deployed. There is no assessment on the impact of the waste water applied to either 800m 2 of "tussock" or 200m of beech forest (see applicants Additional Information). The applicant does not detail sufficient evidence to assure submitters that the system will work in winter at this site. The examples of working dripper irrigation systems are all at warmer, lower altitude sites.
- 8. The vegetation assessment was done as the least optimal time of the year (July 2017) for a vegetation survey. Despite a full year between the assessment and the concession application being notified no update has been provided.





- 9. There is no assessment, thresholds nor monitoring plan for light-pollution; rather, just an offer to keep lighting "to a minimum".
- 10. There is nothing substantial, innovative nor measurable about the proffered blodiversity offsets for the impacts of the development. In fact, it is a mystery why such a project would not present a compelling concrete plan for a conservation gain from the development to win approval from the public. We expected at least an offer of a percentage of the accommodation fee towards the pest control in the Eglinton valley as part of the marketing of the experience. That staff may "assist" in maintaining pest traps and bait lines" in conjunction with DOC is an extraordinarily weak commitment from an applicant who wishes to benefit from the naturalness of the site, and to showcase nature. That accommodation and nature interpretation at this site will "hopefully lead to a longer term-commitment to biodiversity conservation by guests" is an unmeasurable outcome that can be achieved through other encounters with nature anywhere in Fiordland National Park.
- 11. The applicant presents no outline of a programme to systematically survey and remove weeds. Weeds can degrade the existing vegetation and reduce the experience of "natural New Zealand". The biggest impact of soil disturbance from construction and 80m2 of waste water being applied to "tussock" is the introduction and spread of weeds. The worst weeds for the mossy herbfield will be the spread of exotic grasses that can increase the soil moisture and lead to taller vegetation that may shade out the mosses, herbs and lichens. There is no evidence of an intent to remove the Russell lupins in the photo on the front page of the Concept Design.
- 12. "Where possible use weed free sources of gravel to develop the carpark" is optimistically inserted into many consent applications. In our experience this commitment is forgotten with successive staff turnover common in hospitality businesses, and the broom quietly creeps away into the forest and grassland. The commitment to weed control in the Additional Information needs to be tied down at the outset, with a legally binding agreement to an ongoing weed control programme with details of the weed control methods acceptable to the Department.
- 13. For an application that intends to showcase the natural biodiversity, the lack of a survey and assessment of the birds, lizards and bats in the immediate area is puzzling.
- 14. We think the concept of high-value conservation-focussed accommodation and guided nature experience is meritorious. We would like to see it sited outside the Flordland National Park. We think it would benefit from a site on private land where there is more room to develop the site without the formal constraints of a lease from the Department of Conservation. We hope that an alternative site can be found.
