Hi Jill,
The Board made the decision to support the revocation of the 22hectares of Ruahine Forest Park land in consideration for the larger 146 hectare Smedley block at a previous Wellington Conservation Board meeting. Consequently, as a result of the comprehensive Science and Capability Report commissioned by the Dept, the Boards view was reinforced in that the land swap would enhance the conservation values of the land managed by the Department.
This attached report prepared by Martin Williams on behalf of the HBRIC as additional information has been prepared to assist the Hearings Committee in their deliberations.
I can see no reason for the Board to comment on the Williams/HBRIC legal argument.
