1) I have no issue with boat lifters as they provide a good option for keeping a boat out of the water, however I do have an issue with any structure that is left in the water and is not useable. You will have done your research on the boat lifters and know that they need a minimum water level to operate. This boat lifter has not been able to operate since installed as it is too shallow to function.
2) The boat lifter has been used to tie up the boat, but it has never been lifted up with the boat on it. There is a large hole at the back of the lifter, where power loading has been used to try and get the boat up onto the boat lifter.
3) Application for this should have been made before the items were shifted onto the shared jetty without permission. Especially given that the boat lifter would not work in such shallow water. It has now been in the water for over a year and sits on the lakebed when the lake level is low. It is disrespectful of the lake water quality issue that is important, and should never have been left this long contaminating the water. It is also causing damage to the jetty.
4) The jet ski port as you will note the photo on Pg 61 of the application - has always simply been a seat that was built into the wall. It has never had poles for holding a jet ski port. These have been added since that photo to install this platform - which in itself is shocking to leave plastic in the water yearround.
