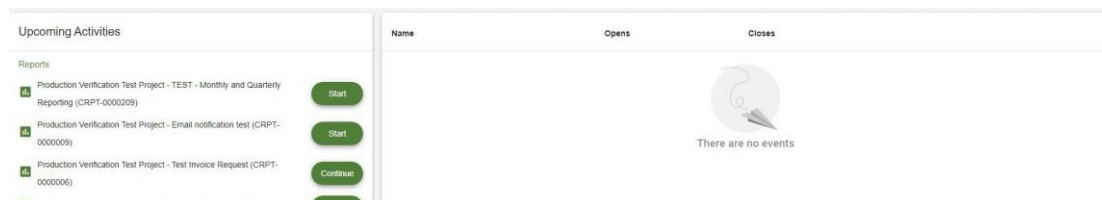


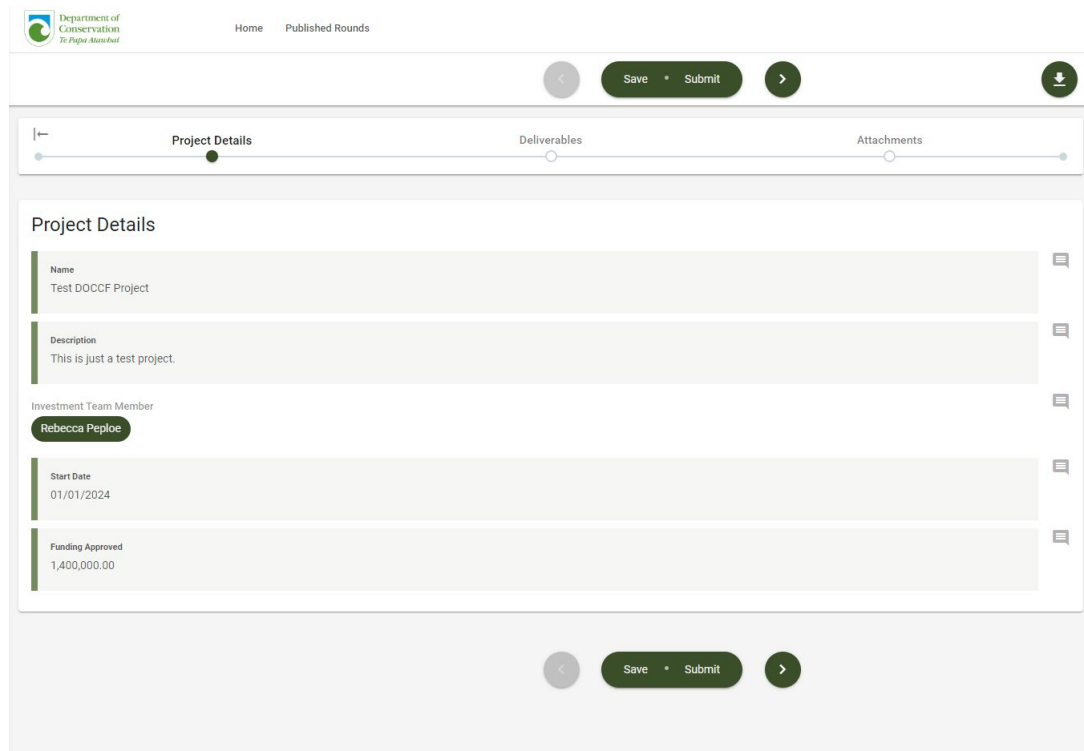
Guide to submitting a report through Enquire

This document offers a step-by-step guide to completing your DOC Community Fund report in Enquire.

1. Your organisation's key contact will receive an email notification advising them that a report is ready for completion and the due date. The email will contain a link to Enquire.
2. Log into Enquire and navigate to the Home page. Any upcoming reports your project has will be listed in the Upcoming Activities box. Click on the Start button next to the report you want to complete.



3. You can now begin your report. On the first page you will see the About Your Project questions. Select the forward arrow button to continue.



4. You will be taken to the Deliverables page. Here you can select each milestone and add commentary on how it has progressed during the reporting period. Click the pencil next to the deliverable to edit the commentary. Enter progress for this reporting period, how complete the deliverable is and if the deliverable is complete, you can check the Milestone Complete box.

Note: all the project's deliverables will be displayed. Only add commentary to the relevant deliverables.

- Below the deliverables, confirm whether you are adhering to the health and safety plan and provide any additional information you may have around health and safety.
- Finally provide a summary of what you have planned for the next quarter. Once you have completed all the fields on the deliverable page, select the forward arrow button to continue or the Save button to save and come back later.

Note: after you have submitted your report, the next time you report, the deliverables page will have the same information that you submitted from the previous report. Please update each section where you have made progress in the current reporting period.
